## 1. About cookies

### 1.1 What are cookies?

A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.

### 1.2 Persistent and session cookies

Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.

### 1.3 Cookies and personal information

Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

## 2. Cookies that we use

### 2.1 Strictly necessary cookies

These cookies are essential for the use of our website and cannot be turned off in our systems.

Cookie	Name	Purpose
Microsoft .NET Session ID	ASP.NET_SessionId	Used to identify a user and distinguish from other users also visiting the site. This is standard as part of Microsoft's .NET platform. This is necessary for the website to function.

## 2.2 Performance cookies

These cookies allow us to anonymously track website statistics, including, page views, traffic source etc. We do this to track our most popular pages and how users move around the site in order to improve our website. We use Google Analytics to do this, which uses first party cookies. The data collected is not shared with anyone else.

## 2.3 Feature cookies

These cookies allow us to remember choices you make on our website and therefore personalise your next visit.

## 2.4 Targeting cookies

These cookies collect information about you in order to deliver more targeted online advertisements. They are also used to measure the effectiveness of online advertisements and can limit the number of times a visitor sees a specific online advertisement. Webnetism do not use any form of targeting cookies. Any change to this will require specific consent from visitors to our website.
